

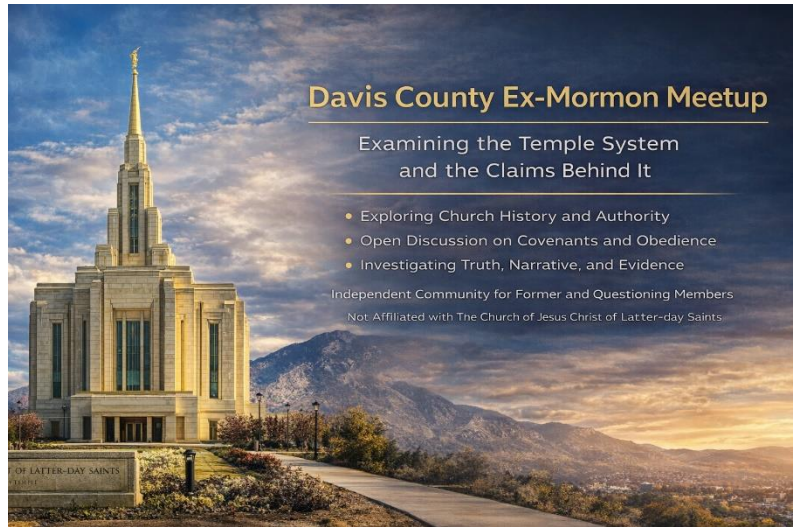
Davis County Ex-Mormon meetup Sunday Aug 39,2026, 2:30 PM

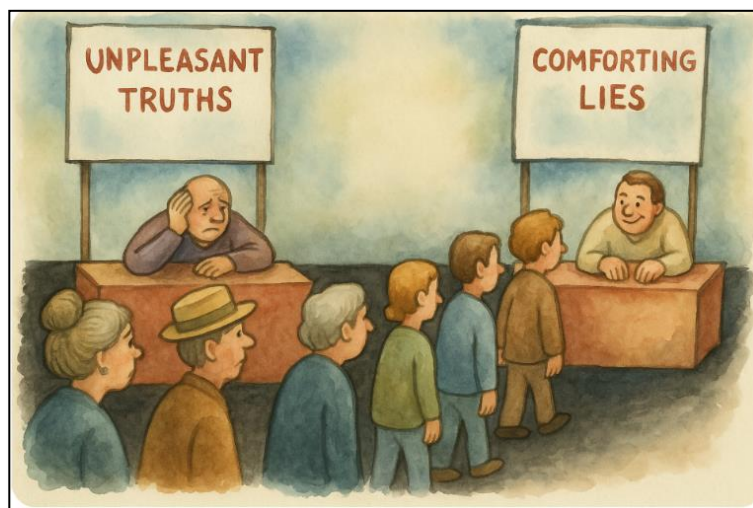
